- 18. The Developer reserves the right to withdraw any lot from sale. 19. If the purchaser has not substantially commenced the home within 24 months after the acquisition date the developer may buy back the property in question in line with the terms and conditions set down in the Contract.

The area to the east of this release is a major sporting and recreational facility including but not limited to four football fields, two round fields, tennis courts, amenities buildings, playgrounds, car parking and other facilities. - 24. The area between Ewing Loop and Howard Loop will contain a dedicated dog off leash area. A current concept plan may be viewed at the Oran Park Town Sales Office
- 25. Secondary dwellings of greater than 60 square metres (including duplexes) will be expressly precluded from being built on lots in Stage 6.
- 26. The following lots are affected by road traffic noise and construction requirements may apply: Category 1 first floor: Lots 6210, 6211. Category 1 both floors: Lot 6201, 6202, 6203, 6204, 6205, 6206, 6207, 6208, 6209, 6212. Dwelling footprint: Lots 6212 and 6209
- 27. All lots in this release include bush fire prone land and construction requirements may apply to achieve BAL ratings. A current BAL affectation map may be viewed at the Oran Park Town Sales Office
- 28. Lots 6202, 6203, 6206, 6207, 6210 and 6211 contain an Asset Protection Zone (APZ) of 10m.
